

*We, the undersigned, feel that the Chairman of Duke College Republicans has repeatedly failed in his capacities as Chair, as detailed below. On behalf of the club, we feel that impeachment actions must be taken.*

- 1) Severe Mishandling of the College Republicans Endorsement for the 2010 DSG Presidential Election
  - a) Refusal to send the endorsement to the listserv
  - b) Waited more than a week to send the endorsement to the Chronicle
    - i) Sent an incorrect endorsement to the Chronicle
  - c) Attempted to trade favors/positions for an endorsement
  - d) Stalled voting procedure in attempt to swing opposing votes in his favor
- 2) Attempted to fix club elections
  - a) Sent emails to members running for positions he did not wish to see them in
  - b) Changed the election rules multiple times during the days leading up to the elections
    - i) The position of Deputy Vice-Chair was intended to be for freshmen, this position was opened up to upper-classmen to prevent them from running for the position of Administrative Vice-Chair
- 3) Continued to send letters in to the Chronicle without clearing them by the Executive board,
  - a) The Chair had previously agreed to allow members of the Executive Board to review his letters to the Chronicle as long as the letters and his signature were related to College Republicans
  - b) The letters that were sent in, including our Young Trustee Endorsement and a personal letter in which the Chair referred multiple times to College Republicans, reflect the club itself in a negative light
- 4) Refusal to call club meetings
  - a) The Chair refused to call a club meeting for a period of three weeks in the aftermath of the DSG endorsement, despite numerous requests from club members
  - b) Failed to engage general body of DCR at any point except for Executive Board meetings which were made open and first meeting of the year
- 5) Neglect of his responsibilities as Chair to coordinate and plan joint events with the UNC College Republicans
  - a) Chair of the UNC College Republicans tried unsuccessfully for more than a week to contact the Chair to coordinate speaker events intended to be jointly planned
  - b) In same vein, Chair blew off opportunity to attend or encourage Board members attendance of Lawson-Roche debate at UNC, made more egregious by DCR's involvement with the campaigns of both Frank Roche and BJ Lawson for Congress
- 6) General conduct unbecoming of a person in a position of leadership
  - a) Ignored and openly flaunted refusal to bring Will Reach to CPAC
  - b) Attempted multiple forced resignations of executive board members
  - c) Repeated offensive and disrespectful treatment of Executive Board members
  - d) Made Executive Board listserv open to non-current or former Executive Board members, in turn not only threatening the integrity of the DCR Executive Board but also compromising the security of private matters discussed on the listserv
- 7) Disregard of Walter Jones Campus Defender Award
  - a) Chairman ignored traditional practice of DCR for 2009-2010 school year
  - b) Disregarded repeated reminders from Executive Director to handle Award issue
